- To Generate Reports for Tracking and Auditing Transactions

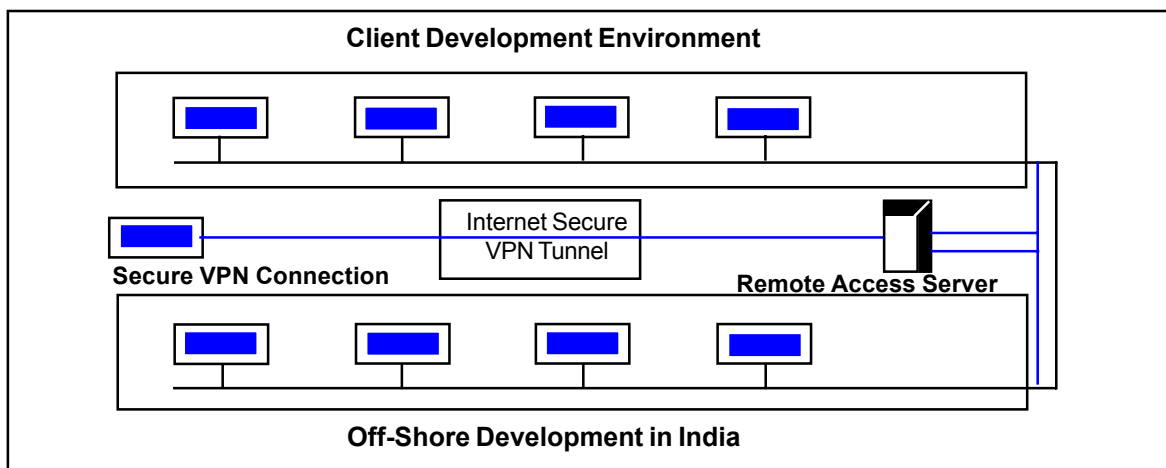

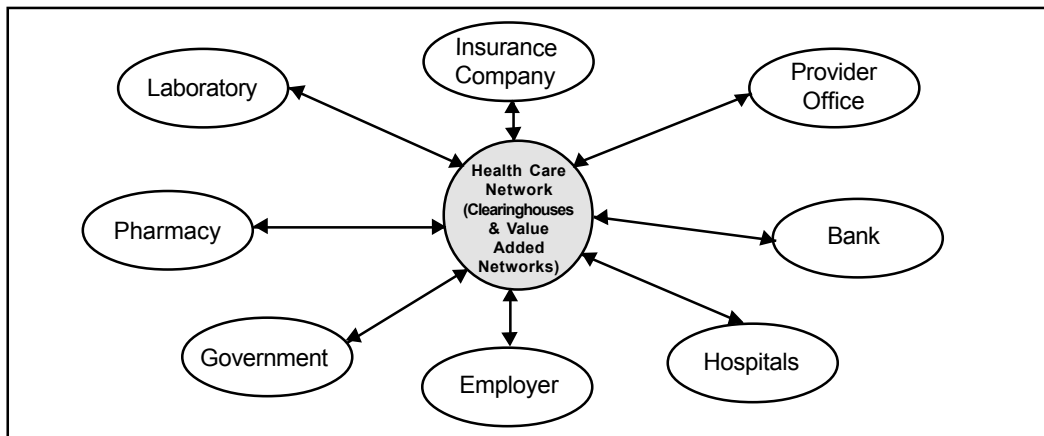
